ORDINANCE NO..

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF GARFIELD; APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA: AND ASSIGNING SUCH TO WARDS

WHEREAS, a petition was filed, pursuant to A.C.A. 14-40-609, for the annexation of certain territory into the City of Garfield, Arkansas; and

WHEREAS, the Benton County Assessor and the Benton County Clerk have (A) Verified the identity of the petitioner(s); (B) Verified that there are no property owners included in the petition that do not wish to have their property annexed; (C) Verified that the property or properties are contiguous with the city; (D) Verified that no enclaves will be created if the petition is accepted by the city; and presented the petition and their respective verifications to the Benton County Judge; and

WHEREAS, the County Judge has (A) Reviewed the petition and verifications for completeness and accuracy; (B) Determined that no enclaves will be created by the annexation; (C) Confirmed that the petition contains a schedule of services; and (D) Issued and order articulating these findings, and forwarded the petition and order to the contiguous City of Garfield for consideration; and

WHEREAS, it is the desire of the Mayor and City Council of Garfield that said territory be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GARFIELD, ARKANSAS:

SECTION 1. That the following territory, contiguous to the City of Garfield, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Garfield, Arkansas to wit:

BEGINNING AT THE NW CORNER OF THE SW 1/4 OF THE SW 1/4 OF SECTION 32 TOWNSHIP 21 NORT RANGE 28 WEST OF BENTON COUNTY, ARKANSAS, ALSO BEING ON THE CITY LIMITS OF GARFIELD, THENCE SOUTH 0 DEGREES 36' 4" WEST, 1155.39 FEET TO A POINT ON THE NORTH RIGHT-OF-WAY ON A CURVE TO THE LEFT WITH A RADUS OF 1108.26 FEET WITH A CHORD OF NORTH 58 DEGREES 02' 23" EAST, 1048.8 FEET; THENCE CONTINUING NORTHWESTERLY ALONG SAID RIGHT-OF-WAY ON A CURVE TO THE LEFT WITH A RADIUS OF 1102.22 FEET WITH A CHORD OF NORTH 19 DEGREES 03' 38" EAST 409.06 FEET; THENCE NORTH 2 DEGREES 46' 18" EAST, 192.45 FEET, TO THE CITY LIMITS OF GARFIELD; THENCE CONTINUING WESTERLY ALONG THE CITY LIMITS NORTH 88 DEGREES 48' 15" WEST, 459.09 FEET; THENCE NORTH 88 DEGREES 48' 15" WEST, 561.76 FEET TO THE POINT OF BEGINNING CONTAINING 19.88 ACRES MORE OR LESS; SAME BEING ALL OF BENTON COUNTY PARCELS #18-02125-000 AND #18-02125-002.

SECTION 2. That the following schedule of services shall be extended to the area by the City of Garfield within the statutorily required three (3) years after the date the annexation becomes final, as follows: Fire Protection- (NEBCO) Immediately; Public Street Maintenance-Immediately; and Zoning and Code Enforcement-Immediately.



SECTION 4. It is the desire of the Garfield City Council the expedite the procedure outlined above. Therefore, it is declared that an emergency exists and the Ordinance is immediately effective
