# AN ORDINANCE AMENDING ORDINANCE NO. 197, AMENDING THE LEGAL DESCRIPTION, DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.

WHEREAS, Ordinance No. 197, has previously been passed by the City Council of the City of Greenwood, Arkansas annexing certain territory into the city limits of the City of Greenwood, Arkansas, and;

WHEREAS, it has come to the Greenwood Council's attention, that the legal description contained in said ordinance contained as error, it is necessary to amend the legal description contained therein to correctly reflect the property annexed into the City of Greenwood.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GREENWOOD. ARKANSAS THAT:

SECTION 1: Ordinance No. 197 is hereby amended, only as far as the following description contained therein, to correctly reflect the proper description of the property annexed into the City of Greenwood, Arkansas. The following shall be amended to the end of the section of Ordinance No. 197 beginning with "JOYCE BELL",

Less and Except: All property lying east of Vache Grasse Recreation Association, Inc., as described in Ordinance No. 197, and all property south of State Highway 10. The Less and Except refers to all property described in the last sentence, lying in the Southwest Quarter of the Northeast Quarter and the Northwest Quarter of the Northeast Quarter in Section 17, Township 6 North, Range 30 West, and the West One-Half of the Northeast Quarter of Section 17, Township 6 North, Range 30 West.

SECTION 2: The City Council of the City of Greenwood, Arkansas having found that this Ordinance is necessary for the preservation of the public peace, health and welfare of the Citizens and Residents of the City of Greenwood, Arkansas, and hereby declares an emergency to exist and this Ordinance shall be in full force and effect from and after its passage and publication.
