A RESOLUTION ANNEXING TO THE CITY OF GREENLAND, ARKANSAS, PROPERTY IDENTIFIED IN "DECREE OF ANNEXATION" ENTERED JUNE 19, 2018, BY THE HONORABLE JOSEPH K. WOOD IN CASE NO. CC-2018-02 IN THE COUNTY COURT OF WASHINGTON COUNTY, ARKANSAS, AND FOR OTHER PURPOSES.

WHEREAS. Petitioner, the City of Greenland, Arkansas is the owner of unincorporated property adjacent to Greenland, and is described as follows,

WHEREAS, the Petitioner prosecuted a petition before the County Court of Washington County, Arkansas, to be annexed into the City of Greenland;

WHEREAS, the annexation petition was heard by the County Court of Washington County, on June 19, 2018, and a "Decree of Annexation" was entered on June 19, 2018.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF GREENLAND, ARKANSAS, that:

Section 1: That the real property described at Exhibit A hereto and situate in Washington County, Arkansas is hereby accepted as an annexation to the City of Greenland, Arkansas.

<u>Section 2</u>: It is hereby determined that the real property described at Exhibit A are contiguous to other property situate in Greenland. Washington County, Arkansas, which is in Ward 1, and therefore the property described in Exhibit A is determined and declared to all be in Ward 1 of the City of Greenland.

Section 3: The official Zoning Map of the City of Greenland, Arkansas, is hereby amended to show the annexation into the City of the real property described in Exhibit A and such property is hereby zoned C-1 to match surrounding properties.

Section 4: The following services shall be extended to the annexed area not later than the date indicated below:

DECREE OF ANNEXATION

NOW on this 19th day of June, 2018, which is a regular day of a regular term of the County Court of Washington County, Arkansas, there is presented to the Court by Mayor Bill Groom, Agent of the Petitioners, a Petition for Annexation of certain territory, hereinafter more particularly described, to the City of Greenland, Arkansas, and the Court being fully advised of the facts and the law, does hereby find, judge and decree as follows:

- 1. That the Petition was filed more than thirty (30) days prior to this date and that in said Petition Mayor Bill Groom was selected by the Petitioners to act on their behalf in filing and presenting the Petition.
- That Notice of the hearing on this matter was published one (1) time a week for three (3) consecutive weeks (April 30, May 7 and May 14 of 2018), as required by A.C.A § 14-40-602; an Affidavit of Publication to that effect having been filed herein on May 21, 2018;
- That a majority of the total number of real estate owners in the area to be annexed 3. by this Petition signed said Petition and that such majority owns more that one-half of the acreage described at Exhibit A.
 - 4. The Court specifically finds that:

That the vast majority of real property being annexed is being developed, by the City and others, as a park for use by the public to have access, with parking, to the west fork of the White River for recreational purposes with the balance of such real property being reserved for proper municipal purposes to be determined as resources become available and such real property is therefore qualified for annexation in accordance with the Vestal criteria <u>Vestal v. City of Little</u> Rock, 54 Ark. 321 (1891).

That within the next thirty-two (32) months trash service will be made available to the real property and immediately upon annexation police protection and fire protection will be available.

The Court further finds that the territory sought to be annexed was accurately described in said Petition and that said territory is contiguous to the boundaries of the City of Greenland, Arkansas.

The Court further finds that attached to and made a part of said Petition as Exhibit B thereto is an accurate map of the territory sought to be annexed to the City of Greenland.

The Court further finds that the prayer of the Petition right and proper.

The Court also finds that attached to the Petition as Exhibit C thereto, is the letter of the Arkansas GIS office confirming coordination by the City of Greenland with ACA § 14-40-101 respecting annexation of the property described in Exhibit A attached hereto.

Therefore, the Court hereby ORDERS, JUDGES AND DECREES that the following described territory be and the same is hereby annexed to and made a part of the City of Greenland, Arkansas, to-wit:

The Court further orders that the original papers in this cause be delivered to the Clerk of Washington County, Arkansas, same to be properly recorded upon the records of Washington

County, Arkansas, and the Clerk, after properly recording and filing the original papers, prepare transcripts of same that one of the certified transcripts be delivered to the City of Greenland, Arkansas, one (1) copy to the Secretary of State and one (1) copy to the Director of the Tax Division of the Arkansas Public Service Commission.


