

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY, LOCATED ON 21.20 ACRES GENERALLY AT 174 CORNERSTONE COURT, TO THE CITY OF HOT SPRINGS, ARKANSAS; MAKING SAME A PART OF THE CITY OF HOT SPRINGS; ASSIGNING SAID LANDS TO A ZONING DISTRICT; ASSIGNING SAID LANDS TO A BOARD DISTRICT; AND FOR OTHER PURPOSES.

WHEREAS, a Petition was filed with the County Clerk of Garland County, Arkansas, pursuant to Arkansas Code Annotated §14-40-601 et seq. by the majority of real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Hot Springs, Arkansas; and that

WHEREAS, on the 27th of July, 2015, the County Court of Garland County, Arkansas, found that the Petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Hot Springs, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Hot Springs, Arkansas; and that

WHEREAS, Hot Springs Code §16-2-32(c) states: Following the entering of an order by the county court granting a petition for annexation, and during the 30 day waiting period during which proceedings may be instituted for having the annexation prevented, the planning commission shall conduct a public hearing to discuss the zoning of the proposed annexed areas and any modifications to the comprehensive plan that might be appropriate; and

WHEREAS, the time fixed by law for appealing from said Order of Annexation made by the County Court has expired, and no appeal has been taken from said Order; and that

WHEREAS, the Petitioners requested C-2(General Business) zone district; and that

WHEREAS, Planning Commission duly advertised and held a public hearing on August 13, 2015, to recommend a permanent zoning classification for the subject property and by unanimous vote recommend the Board of Directors zone the subject property C-2 (General Business District) consistent with the Future Land Use Plan Map designation Linear Commercial Corridor;

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the City of Hot Springs, Arkansas, as follows:

SECTION 1. That the following described lands and territory contiguous to and adjoining the City of Hot Springs, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Hot Springs, Arkansas:

A PART OF THE SOUTHEAST ¼ OF THE NORTHWEST ¼ AND A PART OF THE SOUTHWEST ¼ OF THE NORTHWEST ¼, ALL IN SECTION 21, TOWNSHIP 3 SOUTH, RANGE 19 WEST, GARLAND COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID SOUTHWEST ¼ OF THE NORTHWEST ¼; THENCE SOUTH 88º39'34" EAST ALONG THE NORTH LINE FO SAID SOUTHWEST ¼ OF THE NORTHWEST ¼, A DISTANCE OF 1311.74 FEET TO THE NORTHEAST CORNER OF SAID SOUTHWEST ¼ OF THE NORTHWEST ¼; THENCE SOUTH 88º39'34" EAST, ALONG THE NORTH LINE OF THE SOUTHEAST ¼ OF THE NORTHWEST ¼, A DISTANCE OF 41.92 FEET; THENCE SOUTH 01º39'49" WEST, A DISTANCE OF 178.86 FEET; THENCE SOUTH 80º00'13" WEST, A DISTANCE OF 31.51 FEET; THENCE NORTH 85º08'40" WEST, A DISTANCE OF 382.10 FEET; THENCE SOUTH 01º08'42" WEST, A DISTANCE OF 590.06 FEET; THENCE NORTH 88º29'26" WEST, A DISTANCE OF 693.23 FEET; THENCE SOUTH 01º08'42" WEST, A DISTANCE OF 592.17 FEET TO THE SOUTH LINE OF SAID SOUTHWEST ¼ OF THE NORTHWEST ¼; THENCE NORTH 88º29'26" WEST, A DISTANCE OF 257.4 FEET TO THE SOUTHWEST CORNER OF SAID SOUTHWEST ¼ OF THE NORTHWEST ¼; THENCE NORTH 01º10'44" EAST, A DISTANCE OF 1341.08 FEET TO THE POINT OF BEGINNING AND CONTAINING 21.20 ACRES MORE OR LESS.

<u>SECTION 2.</u> That the above-described territory shall be and is hereby zoned C-2 General Business District, and the zoning map as adopted by the Zoning Code is hereby amended to the extent necessary to designate this zoning classification.

SECTION 3 Future development is subject to local, state, and federal requirements in effect at the time of development.

<u>SECTION 4.</u> That the above-described territory shall be made a part of District 5 of the City of Hot Springs, Arkansas, and the same shall, henceforth, be a part of said District as fully as the existing part of said District.
