AN ORDINANCE ACCEPTING AND APPROVING THE ANNEXATION OF A TRACT OF LAND LYING IN SECTION 11, TOWNSHIP 9 NORTH, RANGE 19 WEST.

ORDINANCE NO.

WHEREAS, there has been presented to the City Conncil, City of Hector, Arkansas, an Order of the Circuit Court of Pope County, Arkansas, dated the 30th day of October, 1979, to annex to the City of Hector, Arkansas the following described tract of lane:

> SURFACE ONLY: The West 1/2 of the Northwest Quarter (NW1/4) of the Northeast Quarter (NE $\frac{1}{4}$) of Section 11, Township 9 North, Range 19 West less and except the following described tracts: JTRACT #1: Part of the West ½ of the Northwest Quarter NW4, of the Northeast Quarter (NE4) of section 11, Town-ship 9 North, Range 19 West described as beginning 200' South of the Northeast corner of the West of the Northwest Quarter (NW%) of the Northeast Quarter (NE%) thence West 210', thence South 105', thence East 210', thence North 105' to the point of beginning, containing .50 acres. TRACT #2: Part of the West 1/2 of the Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) of Section 11, Town-ship 9 North, Range 19 West described as beginning at the Northwest corner of the West's of the Northwest Quarter (NW4) of the Northeast Quarter (NE4), thence South 210', thence East 210' to the point of beginning, thence North 210'; thence East 105', thence South 210', thence West 105' to the point of beginning, containing .50 acres. JTRACT #3: Part of the West & of the Northwest Quarter (NW%) of the Northeast Quarter (NE%) of Section 11, Township 9 North, Range 19 West described as beginning at the Northeast corner of the West's of the NW% of the NE% thence South 515! to the Point of beginning, thence West 210', thence South 105', thence East 210', thence North 105' containing .50 acres.
> TRACT #4: Part of the West 2 of the Northwest Quarter (NW4) of the Northeast Quarter (NE4) of Section 11, Township 9 North, Range 19 West, described as beginning at the Northwest corner of the West's of the NW's NE's thence South 210', thence East 210' to the point of beginning, thence East 210', thence South 105', thence West 210', thence North 105', containing .50 acres.
