



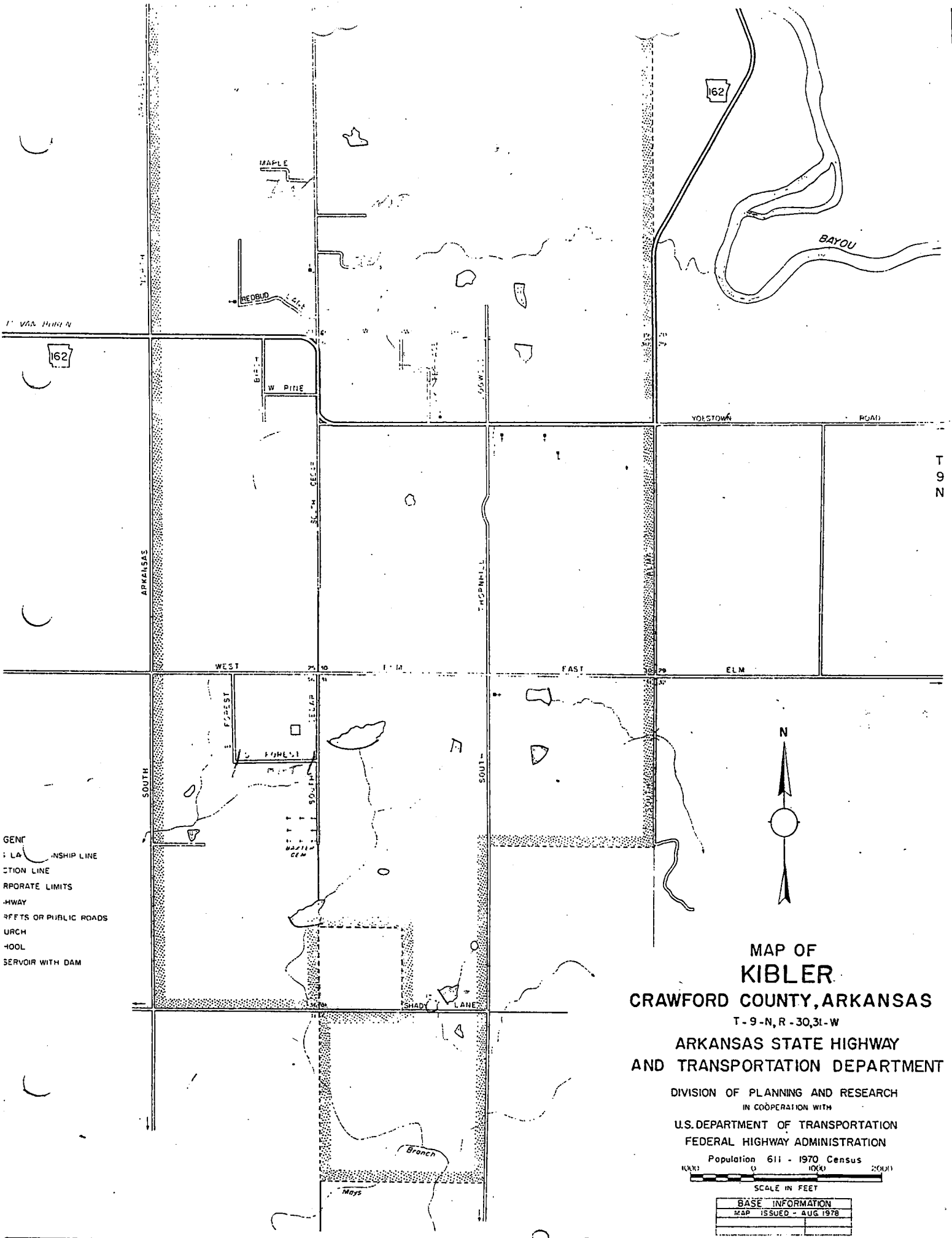

 CRAWFORD COUNTY, ARKANSAS**

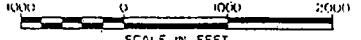



ORDINANCE NO. 88-4

AN ORDINANCE OF THE CITY OF KIBLER, ARKANSAS, FOR THE PURPOSE OF ACCEPTING ADJOINING LANDS WHICH THE ADJOINING LANDOWNERS HAVE PETITIONED TO HAVE ANNEXED TO THE CITY OF KIBLER, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, the City of Kibler, Arkansas, is duly incorporated under the laws of the State of Arkansas, with all powers, authority and duties of a city of the second class, and

WHEREAS, the purpose of this Ordinance is immediately necessary for preservation of the health, safety and welfare of the inhabitants of the City of Kibler, Arkansas, in order to carry out the intent of the statute involved, an emergency exists which requires that this Ordinance become immediately effective and of full force and effect, immediately, and

WHEREAS, the City of Kibler, Arkansas, pursuant to Ark. Code 14-40-601 et seq, and 14-40-605 in particular, in order to complete the annexation commenced by landowners involved, this Ordinance is adopted.

BE IT ORDAINED by the City Council of the City of Kibler, Arkansas:

1. The said Council hereby finds and declares that the facts herein set out are true and correct.

2. All inhabitants of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 14/) of Section 31, Township 9 North, Range 30 West, located in Crawford County, Arkansas, did, on May 18, 1988, file their petition in the County Court of Crawford County, Arkansas for the annexation of the above described adjacent real estate to the City of Kibler, and on the 18th day of May, 1988, notice of said hearing was given for the 27th day of June, 1988, at 10:00 o'clock A. M., in the Crawford County Courtroom, after the County Court of Crawford County had set such hearing by Order dated May 18, 1988, and notice thereof was published in the Press Argus-Courier, a newspaper published in Crawford County, Arkansas, duly qualified to publish legal notices, there being no such newspaper published in the City of Kibler, Arkansas, with such publication having been on the 2nd, 9th and 16th days of June, 1988, and due proof of such publication having been filed in said County Court action, the same being action No. C-88-63, a plat of the lands to be annexed having been also filed in such action, and on the 27th day of June, 1988, at 10:00 A.M., such matter proceeded to hearing in the Crawford

County Courtroom, pursuant to such notice, the County Court of Crawford County, Arkansas, did enter such order of annexation, and more than 30 days have elapsed since the rendition and entry of said Order, and no objection or other notice has been filed by any person or entity, relative to said order, a certified copy of the entire record in such action having been filed with the Recorder of the City of Kibler, and a hearing having been held by the Council of said City relative thereto, and hereby finds that all such facts are true and correct.

3. The Council of the City of Kibler, Arkansas, does hereby accept such annexed lands into the corporate limits of the City of Kibler, Arkansas, and respectfully requests the County Clerk of Crawford County, Arkansas, pursuant to Ark. Code 14-40-605 to forward to the Secretary of State of the State of Arkansas, one copy of the Order of the County Court relative to such annexation, one copy of this Ordinance, and one copy of the plat of the annexed territory, and to likewise forward one copy of said Order of the County Court, one copy of this Ordinance, and one copy of the plat of the annexed territory to the Director of the Tax Division of the Arkansas Public Service Commission.

4. The various paragraphs hereof and portions thereof being severable, should any part hereof be declared invalid, for any reason, the remainder hereof shall continue in full force and effect.

5. The purpose hereof being immediately necessary for the protection of the health, welfare and safety of the inhabitants of the City of Kibler, Arkansas, and an emergency existing, an emergency is hereby found to exist and declared, and this Ordinance shall be and become immediately effective upon its passage and adoption by the City Council of the City of Kibler, Arkansas.

6. All Ordinances and Resolutions, and parts of Ordinances and Resolutions in conflict herewith are hereby repealed.
