ORDER OF ANNEXATION

On this 17th day of October, 2016, is presented to the Court the verified petition of Jerry Cobb, Managing Partner of Cobb Family Farms Partnership, LLLP (CFFP) of Arkansas, praying for an order of annexation to the City of Lake City, Arkansas, as to the following described lands, and based upon such verified petition, notice of hearing and proof of publication thereof, the plat of such land, city map, proof of such ownership, testimony and other proof before the Court, the Court finds:

- 1. That Petitioner, Jerry Cobb, individual residing in Craighead County, Arkansas.

 Petitioner, Jerry Cobb of Arkansas, is operating manager of CFFP and existing under the laws of the State of Arkansas.
- 2. That CFFP is the sole owner of certain real property contiguous to and adjoining the city limits of the City of Lake City, Arkansas, on two sides, and desire for such to be annexed into such city, such real property being located in Craighead County, Arkansas, and more particularly described as follows:

ALL OF LOTS 1 AND 3 OF THE UNITED STATES GOVERNMENT SUPPLEMENTAL SURVEY OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 6 EAST, THAT IS SITUATED IN THE SOUTH HALF OF THE NORTHWEST QUARTER OF SAID SECTION 28 AND LYING EAST OF PURCELL SLOUGH, AND ALL THAT PART OF THE SOUTH HALF OF THE NORTHWESTERN QUARTER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 06 EAST, LYING EAST OF PURCELL SLOUGH, CRAIGHEAD COUNTY, ARKANSAS, CONTAINING APPROXIAMATELY 57 ACRES MORE OR LESS.

- 3. A plat depicting the area to be annexed, as well as a city map depicting the area to be annexed in relation to existing city limits, has been exhibited to, considered and accepted by the Court.
- 4. That CFFP now owns the entire parcel to be annexed, request for annexation, subject to the following described schedule of services.
- 5. The schedule of services to be provide to the above-described real property by the City include water and sewer services upon completion of the planned construction in approximately three years.
- 6. The above-described real property represents the natural growth of the City police Power and services to such area.
- 7. That the allegations of the petition have been sustained by the proof, notice has been properly given, all legal requirements have been met for annexation, and the prayer of the petition is right and proper.
- 8. That the above described real property shall be, and hereby is, annexed into and made a part of the City of Lake City, Arkansas.
