

#### ORDINANCE NO. 2019-<u>07</u>

AN ORDINANCE ANNEXING CERTAIN TERRITORY INTO THE CITY OF LINCOLN, ARKANSAS, MAKING THE SAME A PART OF THE CITY OF LINCOLN, ARKANSAS, AND ASSINGING THE SAME TO A WARD

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LINCOLN, ARKANSAS, THAT:

Section One: Findings. The City Council hereby finds that:

- a. There is territory, consisting of certain real property ("the parcel"), described hereinbelow, adjoining and abutting property owned one hundred percent (100%) by Lincoln Consolidated School District No. 48 ("the owner");
- b. The parcel is not currently within the boundaries of the City of Lincoln, Arkansas. It is wholly within the unincorporated territory of Washington County. However, the parcel is contiguous to the City limits;
- c. The owner of the parcel submitted, in accordance with ARK. CODE ANN. § 14-40-609, a petition for annexation of the parcel into the City of Lincoln to the Washington County Court.
- d. On April 2, 2019, the Washington County Court, Hon. Joseph K. Wood, presiding, entered an Order, incorporating findings of the County Clerk and the County Assessor, finding, among other things, that:
  - (i) The owner's petition and verifications were complete and accurate;
  - (ii) No enclaves would be created by the proposed annexation;
  - (iii) The owner's petition contained a schedule of services;
  - (iv) The proposed annexation consisted of lands that:
    - A. Whether platted or not, are held to be sold as suburban property;

- B. Represent the actual growth of the City of Lincoln beyond its legal boundary; and
- C. Are needed for proper municipal purposes such as the extension of needed police regulations.

The City Council concurs in the County Court's findings and adopts them as its own.

<u>Section Two:</u> <u>Territory Annexed</u>. From and after the date specified below, the parcel, more particularly described as follows, is hereby annexed into, and shall be a part of the body corporate and politic, of the City of Lincoln, Arkansas:

A PART OF THE SOUTHWEST QUARTER (SW 1/4) OF THE SOUTHEAST QUARTER (SE 1/4) OF SECTION TWENTY-NINE (29), TOWNSHIP FIFTEEN (15) NORTH, RANGE THIRTY-TWO (32) WEST OF THE FIFTH PRINCIPAL MERIDIAN, CITY OF LINCOLN, WASHINGTON COUNTY ARKANSAS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTH QUARTER (\$ 1/4) CORNER OF SAID SECTION 29, SAID POINT BEING A FOUND 1 INCH CRIMPED PIPE; THENCE ALONG THE WEST LINE OF SAID SW 1/4 OF THE SE 1/4, N02°35'45"E A DISTANCE OF 495.58 FEET TO THE **POINT OF BEGINNING**, SAID POINT BEING A SET IRON PIN WITH CAP "PLS 1156"; THENCE CONTINUING ALONG SAID WEST LINE, N02°35'45"E A DISTANCE OF 359.93 FEET TO A SET IRON PIN WITH CAP "PLS 1156"; THENCE LEAVING SAID WEST LINE, S87°24'15"E A DISTANCE OF 310.00 FEET TO A SET IRON PIN WITH CAP "PLS 1156"; THENCE N02°35'45"E A DISTANCE OF 376.47 FEET TO THE SOUTHERLY RIGHT OF WAY LINE OF U.S. HIGHWAY 62 (EAST PRIDEMORE DRIVE) AND A SET IRON PIN WITH CAP "PLS 1156"; THENCE ALONG SAID SOUTHERLY RIGHT OF WAY LINE, S86°33'13"E A DISTANCE OF 4.05 FEET TO A POINT; THENCE N86°26'21"E A DISTANCE OF 16.23 FEET TO A SET IRON PIN WITH CAP "PLS 1156"; THENCE LEAVING SAID SOUTHERLY RIGHT OF WAY LINE, S02°28'15"W A DISTANCE OF 737.00 FEET TO A SET IRON PIN WITH CAP "PLS 1156"; THENCE N87°35'31"W A DISTANCE OF 331.80 FEET TO THE POINT OF BEGINNING, CONTAINING 2.91 ACRES, MORE OR LESS, AND SUBJECT TO ALL RIGHTS-OF-WAY, EASEMENTS AND RESTRICTIVE COVENANTS OF RECORD OR FACT.

Section Three: Effective Date. In accordance with ARK. CODE ANN. § 14-40-609, this Ordinance shall become effective from and after 30 days following its passage by the City Council.

Section Four: Compliance with Arkansas Law.

- a. The City Clerk or her duly appointed designee shall, before the effective date of this Ordinance, coordinate with the Arkansas Geographic Systems Office for preparation of legal descriptions and digital mapping for the relevant annexation area, in accordance with ARK. CODE ANN. § 14-40-101.
- b. The City Clerk of her duly appointed designee shall, within forty-five (45) days of the effective date of this Ordinance, forward written notice of the annexation, along with the complete City application for annexation and all other documents pertaining to this annexation in the City's possession, to the Washington County Clerk, in accordance with ARK. CODE ANN. § 14-40-103 (b)(1).

<u>Section Five</u>: <u>Assignment of Ward</u>. Upon the effective date of this Ordinance, and subject to such further action of the City Council in re-drawing ward boundaries, the parcel is assigned to and shall be part of Ward 3 in the City of Lincoln.

<u>Section Six</u>: <u>Schedule of City-Provided Services</u>. The following schedule of services shall be extended to the parcel by the City of Lincoln within the statutorily provided three (3) year period after the date this annexation becomes final, as follows: water service, sewer service, sanitation service, police service, fire service, and ambulance service.

<u>Section Seven</u>: <u>Repealing Clause</u>. Ordinances or parts thereof in effect at the time that this ordinance shall take effect that are in conflict herewith, are repealed.

<u>Section Eight</u>: <u>Saving Clause</u>. Nothing herein shall be deemed to affect any rights or obligations existing at the time of the passage of this ordinance.

Section Nine: Severability Clause. In the event any portion of this ordinance is declared inoperative or invalid as a result of a statute or judicial decision, then only that portion expressly so declared to be inoperative or invalid shall be affected thereby and all other provisions hereof shall remain in full force and effect.

#### ORDER CONCERNING ANNEXATION


