HIGHWAY 10 ANNEXATION (A-334), TO ADD CERTAIN LANDS TO THE CITY OF LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.

WHEREAS, a position for voluntary annexation, (the "Petition") was filed, with the County Clerk of Clerk

WHEREAS, a petition for voluntary annexation, (the "Petition") was filed, with the County Clerk of Pulaski County, Arkansas, using the for 100% property owner method praying that said lands be annexed to and made part of the City of Little Rock, Arkansas; and,

WHEREAS, the County Court of Pulaski County, Arkansas found that the Petition was correct as to: form as required by Arkansas Code 14-40-609; and,

WHEREAS, the Pulaski County Judge signed an Annexation Order for the site requesting annexation (filed February 27, 2019); and,

WHEREAS, an accurate map of said lands has been filed with and made a part of said Petition; and,

In the event any title, section, paragraph, item, sentence, clause, phrase, or word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the ordinance.

Section 4. Repealer. All laws, ordinances or resolutions, or parts of the same, that are in inconsistent with the provisions of this ordinance, are hereby repealed to the extent of such inconsistency.


