Dear Shelby:

My office is in receipt of the 2020 Initial Boundary Validation Program (BVP) from the U.S. Census Bureau. In looking at the maps that were sent for review, we noticed a correction that needs to be submitted to the U.S. Census Bureau.

Madison County's MCD's, townships, and election precincts are considered by Madison County to be one in the same. We use these terms interchangeably, as they refer to the same thing, though in recent years, we mostly use the election precinct verbiage. The order that was submitted to your office on May, 3, 2019 (see attached) effectively updated our MCD's/townships/election precincts, though the verbiage that was used in the order was election precinct. The purpose of this letter is to clarify and confirm that the U.S. Census Bureau's MCD/township maps should be corrected to reflect the changes listed in the May 3, 2019, order.

When we last submitted a Boundary and Annexation Survey (BAS) on paper, which has been several years ago, prior to the Arkansas GIS Office becoming the official state contact, I believe we listed the MCD's as precincts or township/precincts.

Please use this letter as verification and documentation of the changes that needs to be made to the U.S. Census Bureau's MCD maps.

If you should have any questions, or if the U.S. Census Bureau requires any further clarification on our part, please let me know.

IN THE MATTER OF COMBINING, ALTERING AND CHANGING THE PRECINCT BOUNDARIES OF MADISON COUNTY, ARKANSAS AND ESTABLISHING NEW PRECINCTS

WHEREAS: ACA 7-5-101 provides that the County Board of Election Commissioners are empowered to alter the boundaries of existing election precincts and to establish new ones when in its judgment it may be necessary;

WHEREAS: It is hereby considered, ordered and adjudged by the County Board of Election Commissioners that the current election precincts of Madison County, Arkansas are hereby combined, altered and changed to create new election precincts, which shall number ten, and that said new precincts shall be bounded as hereinafter described, and a place appointed to each of said precincts for holding elections as follows:

The new precincts shall be named: Alabam, Hilburn, Kings River, Lamar, Prairie, War Eagle, Ward 1, Ward 2, Ward 3, and Ward 4.

Alabam precinct is hereby bounded as beginning at the Northeast corner of Section 3, Township 18N, Range 25W, thence south and east following the Madison County-Carroll County line to the Southeast corner of Section 17, Township 17N, Range 24W; thence west to the Southwest corner of Section 17, Township 17N, Range 24W; thence south to the Southeast corner of Section 19, Township 17N, Range 24W; thence west to the intersection of the War Eagle River; thence north and west following the meanderings of the War Eagle River to its intersection with County Road 8405; thence north and east along County Road 8405 to the intersection of County Road 8300; thence north and east along County Road 8300 to the intersection of County Road 8615; thence north and east along County Road 8615 to the intersection of County Road 8280; thence north and east along County Road 8280 to the intersection of County Road 8270; thence south and east along County Road 8270 to the intersection of County Road 8715; thence north and east along County Road 8715 to the intersection of Arkansas Highway 23; thence north following Arkansas Highway 23 to the Madison County-Carroll County line; thence south and east following the Madison County-Carroll County line to its intersection with the Kings River; thence south and east following the meanderings of the Kings River to the point of beginning. The place for holding elections shall be the Huntsville Assembly of God Church.

Ward 2 precinct is hereby bounded as beginning at a point at the intersection of Main Street and Polk Street, thence northerly along Polk Street to Cain Street; thence westerly along Cain Street to Gaskill Street; thence northerly along Gaskill Street to the city limit line; thence east along the city limit line to College Street; thence southerly along College Street to Northview Street; thence easterly along Northview Street to Missouri Street; thence southerly along Missouri Street to Missouri Street Reach of Town Branch; thence easterly along said Reach to Town Branch; thence southerly along Town Branch to Main Street; thence westerly along Main Street to the point of beginning. The place for holding elections shall be the Huntsville Assembly of God Church.

Ward 3 precinct is hereby bounded as beginning at a point at the intersection of Town Branch and the north boundary line of the South Quarter of Section 34, Township 17N, Range 26W, thence northerly along Town Branch to the Missouri Street Reach of Town Branch; thence westerly along said Reach to Missouri Street; thence northerly on Missouri Street to Northview Street; thence westerly along Northview Street to College Street; thence northerly along College Street to a point on the city limit line at the south boundary line of the North Quarter of Section 34, Township 17N, Range 26W; thence in a generally clockwise direction along the city limit line to a point on the north boundary line of the South Quarter of Section 35, Township 17N, Range 26W; thence westerly along said boundary line and the north boundary line of the South Quarter of Section 34, Township 17N, Range 26W to the point of beginning, less and except the unincorporated

island, located south of U.S. Highway 412 and generally east of Arkansas Highway 23. The place for holding elections shall be the Huntsville Assembly of God.

Ward 4 precinct is hereby bounded as beginning at a point at the intersection of Town Branch and the north boundary line of the South Quarter of Section 34, Township 17N, Range 26W, thence southerly along Town Branch to Main Street; thence westerly along Main Street to Harris Street; thence southerly along Harris Street; same being Arkansas Highway 23, to the city limit line; thence in a generally counterclockwise direction along the city limit line to its intersection with the north boundary line of the South Quarter of Section 35, Township 17N, Range 26W; thence westerly along said boundary line and the north boundary line of the South Quarter of Section 34, Township 17N, Range 26W to the point of beginning. The place for holding elections shall be the Huntsville Assembly of God Church.

This order shall become effective on May 22, 2019.
