# CITY OF MELBOURNE ORDINANCE NO. 98-04

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MELBOURNE, IZARD COUNTY, ARKANSAS IN MAKING SAME A PART OF THE CITY OF MELBOURNE, ARKANSAS.

WHEREAS, a Petition was filed with the County Clerk of Izard County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory and lands be annexed to, and made a part of, the City of Melbourne, Izard County, Arkansas; and,

WHEREAS, on the 20th day of January, 1998, the County Judge of Izard County, Arkansas, found that the said Petition was signed by a majority of the real estate owners in said territory, both in number and in percentage of ownership of lands, and that said lands that were the subject of the annexation proceeding were continuous to, and adjoining, the present corporate limits of the City of Melbourne, Izard County, Arkansas; that an accurate plat or map of said territory to be annexed has been filed with, and made a part of, said Petition; that proper notice of the hearing on the Petition had been given for the time, and in the manner, prescribed by law; that all things pertaining to the annexation Petition filed by Petitioners had been done in the manner required by Arkansas statute and law; and that said lands and territory should be annexed to, and made a part of, the City of Melbourne, Izard County, Arkansas, subject to the acceptance of the lands into the

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MELBOURNE, IZARD COUNTY, ARKANSAS, AS FOLLOWS:

Section 1: That the following described lands and territory contiguous to, and adjoining, the City of Melbourne, Izard County, Arkansas be, and by the same the said lands are hereby, accepted as part of, and annexed to, the City of Melbourne, Izard County, Arkansas, to-wit:

The SW½ of the NE½; the NW½ of the SE½; all that part of the NW½ of the NE½ that lies South of the Melbourne-Larkin W.P.A. Road in Section 1, Township 16 North, Range 9 West.

ALSO, LESS AND EXCEPT: Part of the SW1 NE1 of Section 1, Township 16 North, Range 9 West, more particularly described as follows: Beginning at a point on the West line of above said SW1 NE1 of Section 1, N 01 deg. 16' E 258.90 feet from the SW corner thereof; thence N 01 deg. 16 E 300 feet to a point; thence S 88 deg. 44' E 631.43 feet to a point; thence S 01 deg. 16' W 300 feet to a point; thence N 88 deg. 44' 631.43 feet to the point of beginning.

ALSO, LESS AND EXCEPT: Part of the SW% of the NE% of Section 1, Township 16 North, Range 9 West, more particularly described as follows: Beginning at a point on the West line above said SW% of NE% of Section 1, N 01 deg. 16' E 558.90 feet from the SW corner thereof; thence N 01 deg. 16' E 278.0 feet to a point; thence S 88 deg. 44' E 631.43 feet to a point, thence S 01 deg. 16' W 278.0 feet to a point; thence N 88 deg. 44' W 631.43 feet to the point of beginning.

ALSO, LESS AND EXCEPT: Beginning at the NW corner of the SWA NEW of Section 1, Township 16 North, Range 9 West, thence South along the West line of said Section 477.25 feet for a true point of beginning, thence S 88 deg. 44' E 631.42 feet; thence N. 01 deg. 16' E 278 feet; thence N. 88 deg. 44' W 631.43 feet; thence S 01 deg. 16' E 278 feet to point of beginning

ALSO, LESS AND EXCEPT: All that part of the SW½ of the NE¼ that lies West of a county road in Section 1, Township 16 North, Range 9 West, being more particularly described as follows: Beginning at the NW corner of said SW¼ NE¼, thence East 100 feet to the centerline of Jacob's Lane, thence South with the meanderings of said Jacob's Lane approximately 200 feet to the North line of the Howard Jacob's Land, thence West to the West line of the SW½ NE¼, thence North along said line to the Point of beginning.

All that part of the S½ of the SE¼ that lies North of Hwy. #69 and West of Mill Creek; and the NW¼ of the SE¼ in Section 1, Township 16 North, Range 9 West.

ALSO, LESS AND EXCEPT: Part of the W½ of the SE¼ of Section 1, Township 16 North, Range 9 West, being more fully described as follows: Beginning at the SW corner of the SW¼ SE¼ of said Section, thence N 01 deg. 16 E 1924.93 feet; thence S 87 deg. 05′ E 910 feet; thence S 01 deg. 16′ W 1735.55 feet; thence S 32 deg. 45′ W 190.53 feet; thence N 87 deg. 43′ W 810.23 feet to the point of beginning.

ALSO, LESS AND EXCEPT: A tract of land being a part of the NE¼ of the SE¼ of Section 1, Township 16 N Range 9 West in Izard County, Arkansas, more particularly described as follows: Beginning at the NW corner of said NE¼ SE¼, thence S 01 deg. 51'36" W along the east line of said NE¼ SE¼, a distance of 164.29 feet; thence N 87 deg. 57'24" W a distance of 300.0 feet; thence S 01 deg. 51'36" W a distance of 100.0 feet; thence N 87 deg. 47'24" W a distance of 474.80 feet; thence N 01 deg. 51'36" E a distance of 261.52 feet to the North line of said NE¼ NE¼; thence S 89 deg. 28'24" E a distance of 775.0 feet to the point of beginning. Containing 4.17 acres, more or less.

the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$ , all that part of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  that lies South of the Melbourne-Larkin W.P.A road in Section 1, Township 16 North, Range 9 West, Izard County, Arkansas

All that part of the S½ of the SE½ that lies North of Hwy. #69 and West of Mill Creek, and NE½ of the SE½ in Section 1, Township 16 North, Range 9 West.

ALSO:

Included in the above described land is Ashley Woods Subdivision, having a total number of 32 Lots as shown by the Recorded Plat thereof.

<u>Section II:</u> Be it further ordained that the City service of providing fire protection shall be extended to the annexed property immediately upon passage of this ordinance and that all remaining City services shall be extended to the annexed property as City funds become available.





Mayor Halbrook,

I believe Shelly may have given you a heads up on a possible correction to Melbourne's city limits as maintained by the state. We were working with Shelly to make sure we have the correct election precincts for the county before we submit them to the Census and found an area where the precincts and possibly the city limits are wrong. She provided the attached ordinance that "less and excepts" the area in question. According to this document and what the county assessor is showing, it makes sense that we may need to remove this part of the city from our map. Before we make changes to the state map for Melbourne, I wanted to get your approval and make sure I interpreted the legal description correctly. Can you please confirm if the below is correct? Also—as an FYI, this correction would create an enclave and I don't believe there were any provisions against doing so in 1998 when the ordinance was filed. If the city should ever want to bring that enclave in, there are relatively new statutes that allow cities to do so by ordinance—if they choose to.
