WHEREAS, the County Court of Crawford County, Arkansas, has forwarded a petition for annexation of lands into Mulberry, Arkansas and an order from Crawford County Court regarding the same annexation to the City of Mulberry, Arkansas, for its consideration;

WHEREAS, Ark. Code Ann. § 14-40-609 provides that a City may grant such a petition and accept the lands for annexation but is not required to grant such petition; and

WHEREAS, after careful consideration, the City Council of Mulberry, Arkansas, believes that it is in the best interests of the City to grant the petition and accept the lands for annexation into the corporate limits of the City of Mulberry, Arkansas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF MULBERRY, ARKANSAS:

SECTION 1: The petition for annexation and subsequent County Court Order is hereby granted.

SECTION 2: The lands described in said petition and also described in the attached Exhibit A, which is hereby incorporated by reference, are hereby accepted for annexation into the City of Mulberry, Arkansas.

SECTION 3: A plat map prepared by the Arkansas GIS of the annexed area is attached hereto as Exhibit B, and hereby incorporated by reference.

SECTION 4: Pursuant to Ark. Code Ann. § 14-40-609 (f)(1), the annexation shall become final thirty (30) days after passage of this resolution.
