### ORDINANCE NO. 1993- 3

AN ORDINANCE TO ANNEX LAND INTO THE CITY LIMITS OF THE CITY OF OZARK, ARKANSAS; DECLARING AN EMERGENCY, AND OTHER PURPOSES.

WHEREAS, a petition was filed in the County Court of Franklin County, Arkansas on the 9th day of February, 1993, for the purpose of annexing certain land into the City Limits of the City of Ozark, Arkansas; and,

WHEREAS, an order has been signed by the county Judge concerning that petition; and,

WHEREAS, no notice has been given within thirty (30) days from the signing of the order of the annexation objecting to such;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS:

SECTION 1. That no notice has been given to prevent the annexation of the lands described on Exhibit A to Petition Nos. 93-01, 93-02, and 93-03, filed in the County Court of Franklin County, Arkansas on the 9th day of February, 1993.

SECTION 2. That the proceedings before the court shall in all things be affirmed, and the City of Ozark accepts the territory listed as Exhibit A in the above listed petitions.

SECTION 3. From the passage and approval of this ordinance, the County Clerk shall be directed to certify one copy of the plat of the annexed territory and one copy of the order of the Court along with the ordinance, and shall forward a copy of each document to the Secretary of State, who shall and preserve them. The Clerk shall take all further measures that are required by law to confirm the annexation to the above referenced petition.

SECTION 4. All legal requirements have been met in order that the above referenced territory may be annexed into the City Limits of Ozark, Arkansas, and this ordinance being necessary for the public peace, safety, health and welfare of the citizens of Ozark, Arkansas, an emergency is declared and this ordinance shall become law upon its passage and approval.
