

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF OZARK, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF OZARK, AND ASSIGNING SAME TO WARDS

WHEREAS, Petition was filed with the County Clerk of Franklin County, Arkansas, by the only real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Ozark, Arkansas; and

WHEREAS, on the <u>8th</u> day of <u>October</u>, 1998, the County Court of Franklin County, Arkansas, found that the Petition was signed by the only real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Ozark, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all thing pertaining thereto had been done in the manner prescribed by law, and that said land and territory should be annexed to and made a part of the City of Ozark, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time affixed by law for appealing from said Order of Annexation made by the County Court has expired and no appeal has been taken from said Order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS:

SECTION 1: That the following described lands and territory contiguous and adjoining the City of Ozark, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Ozark:

Part of the Northwest Quarter of the Southeast Quarter of Section 33, Township 10 North, Range 27 West, Franklin County, Arkansas being more particularly described as follows: Commencing at an existing iron pin marking the Northeast Corner of the Northwest Quarter of the Southeast Quarter. Thence along the East line of said Forty, South 00 degrees 48 minutes 47 seconds West, 398.32 feet to a set rebar and the Point of Beginning. Thence continue along said East line, South 00 degrees 48 minutes 47 seconds West, 572.92 feet to a set rebar. DECREE OF ANNEXATION

MARY E. WILLIAMS COUNTY AND PROBATE CLERK

On this regular day of a regular term of the County Court of Franklin County, Arkansas, there is presented to the Court by Darrell Eubanks and Mary M. Eubanks, a Petition for Annexation of certain territory, hereinafter more particularly described, to the City of Ozark, Arkansas, and the Court being fully advised of the facts and the law, doth hereby find, judge and decree as follows:

The Court finds the Petition was filed more than thirty (30) days prior to this date and that in said Petition, the said Darrell Eubanks and Mary M. Eubanks was selected by himself to present the Petition.

The court doth find that Darrell Eubanks and Mary M. Eubanks are the only persons owning real estate in the area affected by this Petition.

The Court further finds that the territory sought to be annexed was accurately described in said Petition and that said territory is contiguous to the boundaries of the City of Ozark, Arkansas.

The Court further finds that attached to and made a part of said Petition is an accurate map of the territory sought to be annexed to the City of Ozark, Arkansas.
