AN ORDINANCE TO BE ENTITLED "ANNEXATION OF PROPERTY TO THE CITY LIMITS OF PARIS, ARKANSAS"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PARIS, ARKANSAS,

WHEREAS, an Order of Annexation was entered on May 26, 1994, and filed of record on May 26, 1994, in the County Clerk's Office for the Northern District of Logan County, Arkansas.

WHEREAS, no interested party has instituted a proceeding in Circuit Court to have the annexation prevented. That the proceeding should be in all things confirmed and the territory accepted.

NOW THEREFORE, BE IT ORDAINED by the City Council of Paris, Arkansas,

The Southeast Quarter of the Southeast Quarter of Section 4, Township 7 North, Range 26 West, and commencing at the Southeast corner of the Northeast Quarter of the Northeast Quarter Section 9, and running thence North to the North right of way line of State Highway #22, thence West along the said North right of way line of said Highway #22 209 feet for a place of beginning, thence West 332 1/2 feet, thence North 163.8 feet, thence West 61 feet, thence North 132 feet, thence West 299.5 feet, more or less, to a point 418 feet East of the West line of said 40, thence North to the North line of said 40, thence East 693 feet, more or less to a point directly North of the place of beginning, thence South to the place of beginning; in Section 9, Township 7 North, Range 26 West.

LESS AND EXCEPT: Commencing at the Southeast corner of the Northeast Quarter of the Northeast Quarter, Section 9, Township 7 North, Range 26 West, and running thence North to the North right of way line of State Highway #22, thence West along the said North right of way line of said Highway #22 334 feet for a place of beginning, thence West 207.5 feet, thence North 208 feet, thence East 207.5 feet, thence South 208 feet. Said tract conveyed contains 57 1/2 acres.

LESS AND EXCEPT 5 acres owned by Short Mountain Lodge.

Section 2. The inhabitants residing in the above-described property shall have an enjoy all of the rights and privileges of the inhabitants within the original limits of the City of Paris, Arkansas.

Section 3. Any Ordinance, or parts of Ordinances in conflict with the Ordinance are hereby repealed.

Section 4. The declaration of any part of this Ordinance to be null and void shall not serve to void any other part of this Ordinance.

Section 5. The City does not at this point guarantee all City services to the property at the City's expense.

Section 6. This Ordinance being necessary for the immediate preservation of public peace, health and safety, an emergency is hereby declared to exist, and this Ordinance shall take effect and be in force and effect upon passage.

PASSED AND APPROVED by two-thirds (2/3) or more majority of the City of Paris, Arkansas, this 3rd day of October, 1994.





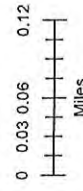
