#### ORDINANCE NO. 580

TENA O'BRIEN CO. & PROBATE CLERK BENTON COUNTY, ARK

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF PEA RIDGE; APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA; AND ASSIGNING SUCH TO WARDS

WHEREAS, a petition was filed, pursuant to A.C.A. 14-40-609, for the annexation of certain territory into the City of Pea Ridge, Arkansas; and

WHEREAS, the Benton County Assessor and the Benton County Clerk have (A) Verified the identity of the petitioner(s); (B) Verified that there are no property owners included in the petition that do not wish to have their property annexed; (C) Verified that the property or properties are contiguous with the city; (D) Verified that no enclaves will be created if the petition is accepted by the city; and presented the petition and their respective verifications to the Benton County Judge; and

WHEREAS, the County Judge has (A) Reviewed the petition and verifications for completeness and accuracy; (B) Determined that no enclaves will be created by the annexation; (C) Confirmed that the petition contains a schedule of services; and (D) Issued an order articulating these findings, and forwarded the petition and order to the contiguous City of Pea Ridge for consideration; and

WHEREAS, it is the desire of the Mayor and City Council of Pea Ridge that said territory be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PEA RIDGE, ARKANSAS:

SECTION 1. That the following described territory, contiguous to the City of Pea Ridge, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Pea Ridge, Arkansas to wit:

Part of the NW ¼ of the NW ¼ of Section 1, Township 20 North, Range 30 West, in Benton County, Arkansas, and including a part of Lot 2, Block 6, Oak Ridge West Addition, and being more particularly described as follows: Commencing at the NW Corner of said NW ¼ of the NW ¼; thence S89°51'E 313.50 feet; thence S00°18'W 37.32 feet; thence S89°51'E 170.00 feet to the true point of beginning; thence S89°51'E 50.00 feet along the South R-O-W line of S.H. 72 (Slack Street); thence S00°18'W 1,157.61 feet; thence West 220.00 feet; thence N00°18'E 947.47 feet; thence S89°30'20"E 170.00 feet; thence N00°18'E 211.74 feet to the P.O.B., containing 5.02 acres, more or less.

SECTION 3. That the above described territory shall be annexed to and made a part of Ward  $\frac{2}{2}$  of the City of Pea Ridge, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Come now the undersigned petitioner(s), and state as follows:

1. That I/we, owning 100% of the property in the following described area, do hereby petition, pursuant to A.C.A. 14-40-609, the City Council of Pea Ridge, Arkansas, to annex the following lands to the City of Pea Ridge, Arkansas:

Part of the NW ¼ of the NW ¼ of Section 1, Township 20 North, Range 30 West, in Benton County, Arkansas, and including a part of Lot 2, Block 6, Oak Ridge West Addition, and being more particularly described as follows: Commencing at the NW Corner of said NW ¼ of the NW ¼; thence S89°51'E 313.50 feet; thence S00°18'W 37.32 feet; thence S89°51'E 170.00 feet to the true point of beginning; thence S89°51' E 50.00 feet along the South R-O-W line of S.H. 72 (Slack Street); thence S00°18'W 1,157.61 feet; thence West 220.00 feet; thence N00°18'E 947.47 feet; thence S89°30'20"E 170.00 feet; thence N00°18'E 211.74 feet to the P.O.B., containing 5.02 acres, more or less.

- 2. I/we further state that this petition is signed by 100% of the real estate owners owning 100% of the acreage in said area.
- 3. That said property described herein is contiguous to and adjoining the present Pea Ridge city limits, as shown on the map attached hereto as Exhibit A.
