Section I. <u>Description of Territory Affected</u>. This ordinance affects the following described real property situated in Lincoln County, Arkansas:

Lot Twenty (20) of the North Half (N 1/2) of Section 4, Township 9 South, Range 7 West of the 5th P. M., containing 40.05 acres, more or less. AND,

Lot Seventeen (17) of the North Half (N 1/2) of Section 5, Township 9 South, Range 7 West of the 5th P. M., LESS AND EXCEPT

All that land lying West of U. S. Highway 425. ALSO, LESS AND EXCEPT



At 10:00 a.m. on the 16th day of March, 2001, in the courtroom in the Lincoln County Courthouse at Star City, Arkansas, there came on to be heard the petition of and certain other landowners praying for an Order of this Court annexing to the City of Star City the following described real property situated in Lincoln County, Arkansas, to-wit:

A. Gibson, Inc., William Owens, Bonnie Owens, John Mahan, Julie Mahan, Ras Brown, Jr., Otheria Brown, Frances Harper and Michael D. Rodgers appearing and Phillip C. Green appearing as designated agent for the petitioners; and upon evidence duly introduced, heard and considered, the Court finds as follows:

- 1. That the above-described real property is continguous to and adjoins the northern boundary of the corporate limits of the City of Star City; and that an accurate map representing said petition and its geographical relation to the City has been made and filed with this Court (attached as Exhibit "A" to the petition) by the petitioners.
- 2. That the petitioners constitute a majority of the total number of real estate owners in the affected area by this annexation, and own more than one-half of the total acres affected, and the requirements for signatures under Arkansas Code Annotated §14-4601 et. seq. have been complied with.
- 3. That the aforementioned petition praying for the annexation of the above-described real property of the City of Star City, Arkansas, correctly describing the property being annexed, having attached thereto an accurate map thereof, and naming Phillip C. Green as the person authorized to act in behalf of the Petitioners, was properly filed on February 12<sup>th</sup>, 2001.
- That by an Order rendered in this proceeding, this Court fixed a time and place for the hearing of said petition being 10:00 a.m. on the 16th day of March, 2001, at the courtroom in the Lincoln County Courthouse; and that said time for hearing was not less than thirty (30) days after the filling of said petition.
- 5. That the petitioners caused a "Notice of Hearing" to be published in the *Lincoln Ledger*, a newspaper published and having a general circulation in the City of Star City, and in Lincoln County where said city is located, in three successive weekly editions of said newspaper, the first publication being made on February 14<sup>th</sup>, 2001; that said notice contained the substance of said petition, stated the time and place appointed for the hearing thereof, and was otherwise in all respects proper.


