

WHEREAS, The City of Stuttgart Corporate Limits adjoins certain real property described as:

WHEREAS, The City of Stuttgart hereby expresses its intent to annex the above described real property following a hearing in the County Court of Arkansas County and expresses its intent to

follow Arkansas Statutory Law to accept the petition to annex once confirmed by the County Court of Arkansas County.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STUTTGART,
ARKANSAS:**

SECTION 1. The City Council of the City of Stuttgart announces its intent to participate and accept, following appropriate review by the County Court of Arkansas County, and in accordance with Arkansas Statutory Law, annexation of the above described real property adjoining the Corporate Limits of the City of Stuttgart.






