



ORDINANCE NO. 2014- *9*

AN ORDINANCE FOR THE PURPOSE OF ANNEXING CERTAIN TERRITORY TO THE CITY OF SHERIDAN, ARKANSAS, AND FOR OTHER PURPOSES.

WHEREAS, a petition was filed with the County Clerk of Grant County, Arkansas, signed by the owners, or agent therefor, of the hereinafter described lands asking that said territory be annexed to and made a part of the City of Sheridan, Arkansas; and,

WHEREAS, on the 14th day of August, 2014, the County Court of Grant County, Arkansas, ordered that said petition would be heard on the 13th day of October, 2014, at 10:00 a.m., said date being not less than thirty days after the filing of said petition; and

WHEREAS, on the 13th day of October, 2014, the County Court of Grant County, Arkansas, found that the petition was signed by the owners of said property; that the land was properly described; that an accurate map thereof was made and filed; that the territory is contiguous to and adjoining the City of Sheridan, Arkansas; that notice of said annexation was published in the Sheridan Headlight, a newspaper having a bona fide circulation in this county, describing the territory in said notice as directed by the order of said County Court and for the time and in the manner provided by law; and more than thirty days have expired since the order of annexation made by the County Court and all exceptions presented by land owners have been heard by the Court in the time and manner provided by law and the order of annexation has been made by the County Court and the said annexation has been made by the County Court and the annexation is final and complete and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHERIDAN, ARKANSAS:

Section 1: That the following described land and territory is contiguous to and adjoining to

the City of Sheridan, Arkansas, to-wit:

Part of the Southeast Quarter (SE1/4) of the Northeast Quarter (NE1/4) of Section Eight (8), Township Five (5) South, Range Thirteen (13) West, Grant County, Arkansas, described as: Beginning at the NE corner of the SE1/4 NE1/4 of said Section 8, run thence West 664 feet, thence South 495 feet, thence East 136 feet, thence South 825 feet, thence East 528 feet, thence North 1320 feet to the Point of Beginning, containing 17.6 acres, more or less.

And Also:

The Southwest Quarter (SW1/4) of the Northwest Quarter (NW1/4) of Section Nine (9), Township Five (5) South, Range Thirteen (13) West, Grant County, Arkansas, containing 40 acres, more or less.

and that portion of the real property not currently in the City of Sheridan, is hereby accepted as part of and annexed to and made a part of the territory of the City of Sheridan, Arkansas.

Section 2. The said property is hereby declared to be a part of Ward ____ of the City of Sheridan, Arkansas.

Section 3. This ordinance being necessary for the preservation of the peace, health and safety of the citizens of the City of Sheridan, Arkansas, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect from and after its passage.
