ORDINANCE NO. 13-45

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN & PROBATE CLERGE TERRITORY TO THE CITY OF SILOAM SPRINGS, ARKANSAS, NTON COUNTY, ARE AND MAKING SAME A PART OF THE CITY OF SILOAM SPRINGS, ARKANSAS, AND ASSIGNING SAME TO A WARD.

WHEREAS, petition was filed with the County Clerk of Benton County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Siloam Springs, Arkansas; and,

WHEREAS, on October 22, 2013, the County Court of Benton County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Siloam Springs, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Siloam Springs, Arkansas, subject to the acceptance of same by the City Board of Directors of said City at the proper time, as provided by law; and,

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE City Board of Directors of the City of Siloam Springs, Arkansas:

Section 1. That the following described lands and territory contiguous and adjoining the City of Siloam Springs, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Siloam Springs, Arkansas:

A part of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section Thirty-Two (32) and a part of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of the

Northwest Quarter (NW 1/4) of Section Thirty-three (33), all in Township Eighteen (18) North, Range Thirty-three (33) West, being more particularly described as follows:

Commencing at a metal fence corner post at the Northeast corner of said Section Thirty-two (32); thence South 02 degrees 53 minutes 06 seconds West 1319.25 feet to a 1/2 inch iron rebar at the Northeast corner of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of said Section Thirty-two (32) for the true point of beginning; thence South 02 degrees 53 minutes 06 seconds West 659.62 feet to a 1/2 inch iron rebar at the Northwest corner of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of said Section Thirty-three (33); thence South 87 degrees 23 minutes 49 seconds East 410.62 feet to a set 1/2 inch iron rebar; thence South 02 degrees 53 minutes 15 seconds West 601.40 feet to a set 1/2 inch iron rebar on the North right-of-way of Cheri Whitlock Drive (Route 43); thence North 86 degrees 43

minutes 18 seconds West along said right-of-way 497.79 feet to an existing AHTD survey nail; thence continuing along said right-of-way North 87 degrees 17 minutes 53 seconds 14 JAN -3 AH 9: 16 West 290.15 feet to a 1/2 inch iron rebar; thence leaving said right-of-way North 02 degrees 53 minutes 06 seconds East 1259.72 feet to a 1/2 inch iron rebar on the North line TENA OF REPARE CLERE of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of said Section RENT ON COUNTY, AE point of beginning, containing 16.54 acres, more or less. Subject to any easements and/or rights-of-way, whether or not of record.

Section 2. That the above described territory shall be annexed to and made a part of Ward 2 of the City of Siloam Springs, Arkansas, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 3. That the zoning map of the City (Municipal Code Section 102-21) is hereby amended to include within the G-I zoning district the above described territory.

DECREE OF ANNEXATION

On this 22nd day of October, 2013, a day of the regular term of the County Court of Benton County, Arkansas, there is presented to the court by the petitioners or Gary Wheat, their agent, a Petition for annexation of certain territory, hereinafter more particularly described, to the City of Siloam Springs, Arkansas, and the Court being fully advised of the facts and the law, doth hereby find, judge and decree as follows:

- 1. The Court finds that the Petition for annexation was filed in the office of the Clerk of this Court more than thirty (30) days prior to this date.
- 2. The Court doth find that a majority of the total number of real estate owners in the area affected by the Petition has signed said Petition and that such majority owns more than one-half of the acreage affected.
- 3. The Court further finds that the territory sought to be annexed was accurately described in said Petition, or as amended, and that said territory is contiguous to the boundaries of the City of Siloam Springs, Arkansas.
- 4. The Court further finds that attached to and made a part of said Petition is an accurate map of the territory sought to be annexed to the City of Siloam Springs, Arkansas.

Subject to any easements and/or rights-of-way, whether or not of record.



Upon doing so, the City of <u>Siloam Springs</u> shall return one certified copy of its ordinance or resolution to the County Clerk.

Thereafter, the County Clerk shall deliver one copy each of this Order and the ordinance or resolution of the City of Gravette accepting this annexation to the Secretary of State, and one copy to the Director of the Tax Division of the Arkansas Public Service Commission.
