

ORDINANCE NO. 642-2018



AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF TRUMANN AND APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA

WHEREAS, a petition was filed, pursuant to Arkansas Code Annotated section 14-60-609, for the annexation of certain territory in the city of Trumann, Arkansas; and

WHEREAS, the Poinsett County Assessor and the Poinsett County Clerk have (A) verified the identity of the petitioners; (b) verified that there are no property owners included in the petition that do not wish to have their property annexed; (C) verified that the property or properties are contiguous with the city of Trumann; (D) verified that no enclaves will be created if the petition is accepted by the city of Trumann; and presented the petition and their respective verifications to the Poinsett County Judge; and

WHEREAS, the County Judge has (a) reviewed the petition and verifications for completeness and accuracy; (B) determined that no enclaves will be created by the annexation; (C) confirmed that the petition contains a schedule of services—police protection; (D) found that the land to be annexed is valuable by its adaptability for prospective municipal uses; and issued an order articulating these findings and forwarded the petition and order to the contiguous city of Trumann for consideration; and

WHEREAS, it is the desire of the City Council of Trumann that said territory by annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TRUMANN, ARKANSAS:

SECTION 1. That the following described territory, contiguous to the city of Trumann, be and the same is hereby accepted as part of, and annexed to and made a part of the city of Trumann, Arkansas:

The NW NE of Section 16, Township 12 North, Range 5 East and the East ½ of the Northeast ¼ of Section 16, Township 12 North, Range 5 East not already within the City of Trumann.

Also, the West ½ of the Northwest ¼ of Section 15, Township 12 North, Range 5 East not already within the City of Trumann.

To include the portions of I-555 and its right of ways that lie within the above described D Quarter and half-sections

DECREE OF ANNEXATION

On this regular day of a regular term of the County Court of Poinsett County, Arkansas, there is presented to the Court by Jimmy Gazaway, counsel for the city of Trumann, Arkansas and agent of the Petitioners, having been authorized to act on behalf of the Petitioners, the petition for annexation of certain territory, hereinafter more particularly described, to the city of Trumann, Arkansas, and the Court being fully advised of the facts and the law, does hereby find, judge and decree as follows:


- 1. The Court finds that the petition was filed more than thirty (30) days prior to this date and that in said petition Jimmy Gazaway, counsel for the city of Trumann, was selected by the petitioners to act on their behalf in filing and presenting the petition. The Court finds that the petition and verifications are complete and accurate and that all necessary time periods have elapsed.
- 2. The Court further finds that Notice of the Hearing on this matter was published one (1) time a week for three (3) consecutive weeks as required by Ark. Code Ann. 14-40-602.

The Court finds that the majority of the total number of real estate owners in the area affected by this petition have signed said petition and that such majority owns more than one-half of the acreage affected.

The Court further finds that the territory consists of lands that are valuable by reason of their adaptability for prospective municipal use.

5. The Court further finds that the territory sought to be annexed was accurately described in said petition and that said territory is contiguous to the boundaries of the City of Trumann, Arkansas.

- 6. The Court further finds that attached to and made part of said petition is an accurate map of the territory sought to be annexed to the City of Trumann,

- 7. The Court further finds that the prayer of the petition is right and proper.
- 8. The Court further finds that no enclaves will be created by the annexation.
- 9. The Court finds that the petition contains a schedule of services.
- 10. The Court finds that no person appeared in the office of the County Judge at the hearing on the date set forth in the Notice of Hearing that was publishes as evidenced by the Proof of Publication to contest or oppose the annexation and that the annexation of the territory described herein to the City of Trumann, Arkansas is hereby affirmed by the Court.
- 11. The Court orders that the City shall provide police protection to the territory described herein within three (3) years of the date the annexation becomes final.

THEREFORE, the Court hereby ORDERS, JUDGES and DECREES that the following described territory, as set forth in the map attached to the petition, be and the same is hereby annexed to and made a part of the City of Trumann, Arkansas, to wit:

The NW NE of Section 16, Township 12 North, Range 5 East and the E ½ of the NE ¼ of Section 16, Township 12 North, Range 5 East not already within the City of Trumann.

Also, the W ½ of the NW ¼ of Section 15, Township 12 North, Range 5 East not already within the City of Trumann.

To include the portions of I-555 and its right of ways that lie within

The Court further orders that the original papers in this cause be delivered to the Clerk of Poinsett County, Arkansas, the same to be properly recorded upon the records of Poinsett County, Arkansas, and the Clerk, after properly recording and filing the original papers, prepare transcripts of same; that one of the certified transcripts be delivered to the City of Trumann, Arkansas, one copy to the Secretary of State, and one copy to the Director of the Tax Division of the Arkansas Public Service Commission.


