ORDINANCE 478

AMENDING ORDINANCE 346 TO CORRECT A SCRIVENER'S ERROR

WHEREAS, Donald and Louise Elkins petitioned the Washington County Court seeking approval to annex 11.94 acres into the City of West Fork on May 17, 2001 (CC-2001-11); and

WHEREAS, the County Court, on June 18, 2001, issued an Order granting the annexation request; and

WHEREAS, the West Fork City Council passed Ordinance No. 346 on July 10, 2001 approving the annexation; and

WHEREAS, in the course of preparing for the 2020 Census, it has come to attention that there was a scrivener's error in said Ordinance; and

WHEREAS, to effectuate and insure the correct reporting of city limit boundaries to the U.S. Census Bureau, the correction of the scrivener's error is necessary.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST FORK, ARKANSAS:

SECTION 1. The legal description contained in Ordinance No. 346 is hereby amended to read as follows:

A part of the N ½ of the SW ¼ of the SW ¼ of S22, T15N, R30W, being more particularly described as follows, to-wit: Beginning at a point which is N89°49'19" E 795.61' from the NW corner of said 40 acre tract; thence S00°15'05" E 726.02'; thence S86°31'19" E 696.13'; thence N00°15'05" E 770.44' to the North line of said 40 acre tract; thence S89°49'12" W 695.05' to the P.O.B. Containing 11.94 acres, more or less.

SECTION 2. The City Clerk is directed to file a duly certified copy of this Ordinance in the Office of the Washington County Clerk.





> A part of the North Half (N1/2) of the Southwest Quarter (SW1/4) of Section Twenty Two (22), Township Fifteen (15) North, Range Thirty (30) West, being more particularly described as follows, To-Wit: Beginning at a point which is N89deg49'19"E 795.61 feet from the Northwest corner of said 80 acre tract, and running thence S00deg15'05"W 726.02 feet to an existing fence, thence S86deg31'19"E along existing fence 696.13 feet, thence N00deg15'05"E 770.44 feet to the North line of said 80 acre tract, thence \$89deg49'12"W along existing fence 695.05 feet to the point of beginning. Containing 11.94 acres, more or less.

THE COURT BEING WELL AND SUFFICIENTLY ADVISED IN THE PREMISES FINDS:

- That said Petition was duly filed on May 17th, 2001. 1.
- 2. That the Court fixed the 18th day of JUNE, 2001, as the date of hearing on said Petition, and Notice of the filing of said Petition, and the date, time and place of hearing thereon was


published in the time and manner required by law, by publication once a week for two (2) consecutive weeks in the White River Valley News, a newspaper of general circulation in Washington County, Arkansas.
