

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MENA, POLK COUNTY, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MENA AND ASSIGNING SAME TO WARDS

WHEREAS, petition was filed with the County Clerk of Polk County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the city of Mena, Arkansas; and,

WHEREAS, on the <u>2nd</u> day of October, 1989, the County Court of Polk County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Mena, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the city of Mena, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MENA, ARKANSAS:

Section 1. That the following described lands and territory contiguous and adjoining the City of Mena, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Mena, Arkansas.

The Southeast Quarter of the Northeast Quarter and the Northeast Quarter of the Northeast Quarter of Section 7, Township 2 South, Range 30 West. ALSO the Southeast Quarter of the Southeast Quarter of Section 6, Township 2 South, Range 30 West; the South one-half of the Southwest Quarter of the Southeast Quarter of Section 6, Township 2 South, Range 30 West and the South threequarters of the Northeast Quarter of the Southwest Quarter of the Southeast Quarter of Section 6, Township 2 South, Range 30 West and the South threequarters of the Northeast Quarter of the Southwest Quarter of the Southeast Quarter of Section 6, Township 2 South, Range 30 West; The Southwest Quarter of the Southwest Quarter of Section 5, Township 2 South, Range 30 West, Polk County, Arkansas.

LESS AND EXCEPT: A 2.38 acre tract located in the Northeast Corner of said Quarter Section more particularly described as follows: Commencing at the Northeast Corner of said Quarter Section; thence West a distance of 255.48 feet along the Northern boundary of said Quarter Section; thence South 140 degrees, 37. minutes, 36 seconds West a distance of 344.51 feet; thence South 86 degrees, 08 minutes East 348.17 feet; thence North along the East line of the Quarter Section line a distance of 354.77 feet to the point of beginning.

Section 2. That the above described territory shall be annexed to and made a part of Ward 2 of the City of Mena, Arkansas, and the same shall henceforth shall be a part of said ward as fully as existing parts of said ward.

## DECREE OF ANNEXATION

On this 2nd day of October, 1989, there is presented to the County Court by ORVIN W. FOSTER, agent of the petitioners, a petition for annexation of certain territory, herein more particularly described, to the City of Mena, Arkansas, and the Court being fully advised of the facts and the law, doth hereby Find, Adjudge and Decree as follows:

The Court finds that the petition was filed more than thirty (30) days prior to this date; that in said petition, ORVIN W. FOSTER was selected by the petitioners to act on their behalf in filing and presenting the petition; and that notice has been published as required by law. A public hearing has been held pursuant to Arkansas Statute and no one appeared in opposition to the petition filed herein.

The Court doth find that a majority of the total number of real estate owners in the area affected by this petition have signed said petition and that such majority owns more than one-half of the acreage affected.

The Court further finds that the territory sought to be annexed was accurately described in said petition and that said territory is contiguous to the boundaries of the City of Mena, Arkansas.

The Court further finds that attached to and made a part of said petition is an accurate map of the territory sought to be annexed to the City of Mena, Polk County, Arkansas.

The Court further finds that the prayer of the petition is Uright and proper and should be granted.

Therefore, the Court doth hereby ORDER, ADJUDGE and DECREE that the following described territory be and the same is hereby annexed to, and made a part of the City of Mena, Polk County,
