

ORDINANCE NO. 3-78

AN ORDINANCE APPROVING ANNEXATION OF TERRITORY AND ACCEPTING SAID TERRITORY INTO THE INCORPORATED TOWN OF MINTURN, ARKANSAS.

WHEREAS, Ronnie Light and Kathee Light, the sole owners of the hereinafter described property, filed in the County Court for Lawrence County, Arkansas, their petition seeking the annexation of the following lands to the Incorporated Town of Minturn, Arkansas, the same lying in Lawrence County, Arkansas, and being described as follows, to-wit:

All of the Northwest Quarter (NW_A^1) of the Northeast Quarter (NE_A^1) of Section Thirty-One (31), Township Sixteen (16), Range One (1) East, lying West of the Railroad, and that a plat of same is attached hereto as Exhibit "A".

WHEREAS, said petition was filed in said Court on February 3, 1978, and said Court set the date for hearing thereon at 10:00 A.M., March 9, 1978, in the courthouse in Walnut Ridge, Arkansas;

WHEREAS, said petitioners caused a notice of said hearing to be published
in the Times Dispatch, a paper of general circulation in Lawrence County,

Arkansas, the same having been published once a week for three consecutive weeks;

WHEREAS, a hearing was had on said petition at 10:00 A.M. on March 9, 1978 before the County Court of Lawrence County, Arkansas, pursuant to said notice;

WHEREAS, the Court at said hearing determined that all requirements of the law of the State of Arkansas had been followed in the preparation and presentation of said petition; that the allegations therein were sustained by the proof; that the limits of the territory to be annexed had been accurately described and an accurate map thereof made and filed, thereupon made its order granting the petition and annexing said territory to the Incorporated Town of Minturn, Arkansas;

WHEREAS, more than thirty days have elapsed since the entry of said order of said Court and no objection has been made thereto by any party whatsoever.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE INCORPORATED TOWN OF MINTURN, ARKANSAS, that the proceedings before said County Court of Lawrence County, Arkansas, be in all things confirmed, and that the Incorporated Town of Minturn, Arkansas, accept said territory and that same be, and hereby is, annexed to the Incorporated Town of Minturn, Arkansas, and that the aforesaid lands be deemed and taken to be a part and a partial of the limits of said Minturn, Arkansas, and the inhabitants residing therein shall have and enjoy all the rights and privileges of the inhabitants within the original limits of Minturn, Arkansas, with the adoption hereof.

Enacted and Ordained by the Council of the Incorporated Town of Minturn, Arkansas, this 2 day of May , 1978, by a vote of 7 yeas and 0 nos.



Now this day comes on for hearing the petition of Ronnie Light and
Kathee Light in which it has been proposed to annex the following lands lying
in Lawrence County to the Incorporated Town of Minturn, Arkansas, to-wit:

All of the Northwest Quarter (NW*) of the Northeast Quarter (NE*) of Section Thirty-One (31), Township Sixteen (16) North, Range One (1) East, lying West of the Missouri-Pacific Railroad, and a plat of same is attached hereto as Exhibit "A".

That upon examination of said petition, notice of filing thereof, plat attached thereto, proof of publication thereof, oral testimony on behalf of the petitioners by Tom L. Hilburn, and other evidence, matters and things appearing before the Court, the Court doth find:

That petition herein filed is signed by majority of property owners seeking annexation to the Incorporated Town of Minturn, Arkansas; that said annexation of said property will be conducive to the public health, convenience and welfare, and will be of public utility and benefit; and that it will be to the advantage of all the owners thereof that said land be annexed to the Incorporated Town of Minturn, Arkansas; that the notice of filing of said petition and notice of hearing upon said petition was duly given for the time and in the manner required by law; that no one appeared at said hearing to show cause why said property should not be annexed to the Incorporated Town of Minturn, Arkansas.

It is therefore by the Court considered, ordered, and decreed that the hereinabove described property for annexation to the Incorporated Town of Min-turn, Arkansas, is hereby annexed thereto upon acceptance by the Council of the Incorporated Town of Minturn, Arkansas.
