

ORDINANCE NO. 202

WHEREAS, petition was filed with the County Clerk of the Pike County Arkansas, by the majority of the real estate owners hereinafter described territory praying territory be annexed to. and made a part of the City of Murfreesboro, Arkansas, and,

WHEREAS, on the 6th day of September, 1996, the County Court of Pike County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Murfreesboro, Arkansas; that an accurate plat or map of said territory had been filed with, and made a part of said petition; that proper notice has been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of Murfreesboro, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MURFREESBORO, ARKANSAS.

SECTION 1. That the following described lands and territory contiguous and adjoining the City of Murfreesboro, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Murfreesboro.

Beginning at the Southeast corner of the Northeast Quarter (NE%) of the Southwest Quarter (SW%) of Section five (5), Township Eight (8) South, Range Twenty ve (25) West, thence run North 429 feet; thence run West 110 feet to the point of Beginning; thence run West ten (10) feet to the Murfreesboro City Limits; thence run South 35 yards along the Murfreesboro City Limits line; thence run East 70 yards thence run North 35 yards; thence run West 70 yards to the Murfreesboro City limits line, containing 0.5 acre, more or less.

Beginning at the Southeast corner of the Northeast Quarter (NE%) of the Southwest Quarter (SW%) of Section five (5), Township eight (8) South, Range Twenty five (25) West, thence run North 429 feet; thence run West 1100 feet to the point of beginning; thence run North 70 yards; thence East 170 yards; thence South 70 yards and thence West 170 yards to the point of beginning, containing two and one half (2½) acres, more or less.

That the above described territory shall be annexed to and made a part of the //arth Ward of the City of Murfreesboro, and the same shall henceforth be a part of said ward as fully as existing parts of said Ward.

Section 3. This Ordinance being necessary protection and preservation of public health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force and shall take effect upon passage and publication.



ORDER

Now on this 6th day of September, 1996, there is presented to the Court by Mobie Price a petition for annexation of certain territory, herein after more particularly described, to the City of Murfreesboro, Arkansas, and the Court bein fully advised of the facts and of the law, doth hereby find, adjudge, and decree as follows:

- 1. The Court finds that the petition was filed more than 30 days prior to this date and that in said petition the said Mobie Price was selected by the petitioners to act on their behalf in filing and presenting the petition.
- 2. The Court finds that majority of the total number of real estate owners in the area affected by this petition have signed said petition and that such majority owns more than onehalf of the acreage affected.
- The Court further finds that the territory sought to be annexed was accurate described in said petition and that said territory is contiguous to the boundaries of the City of Murfreesboro, Arkansas.
- The Court further finds that attachecd to and made a part of said petition is an accurate map of the territory sought to be annexed to the City of Murfreesboro.
