

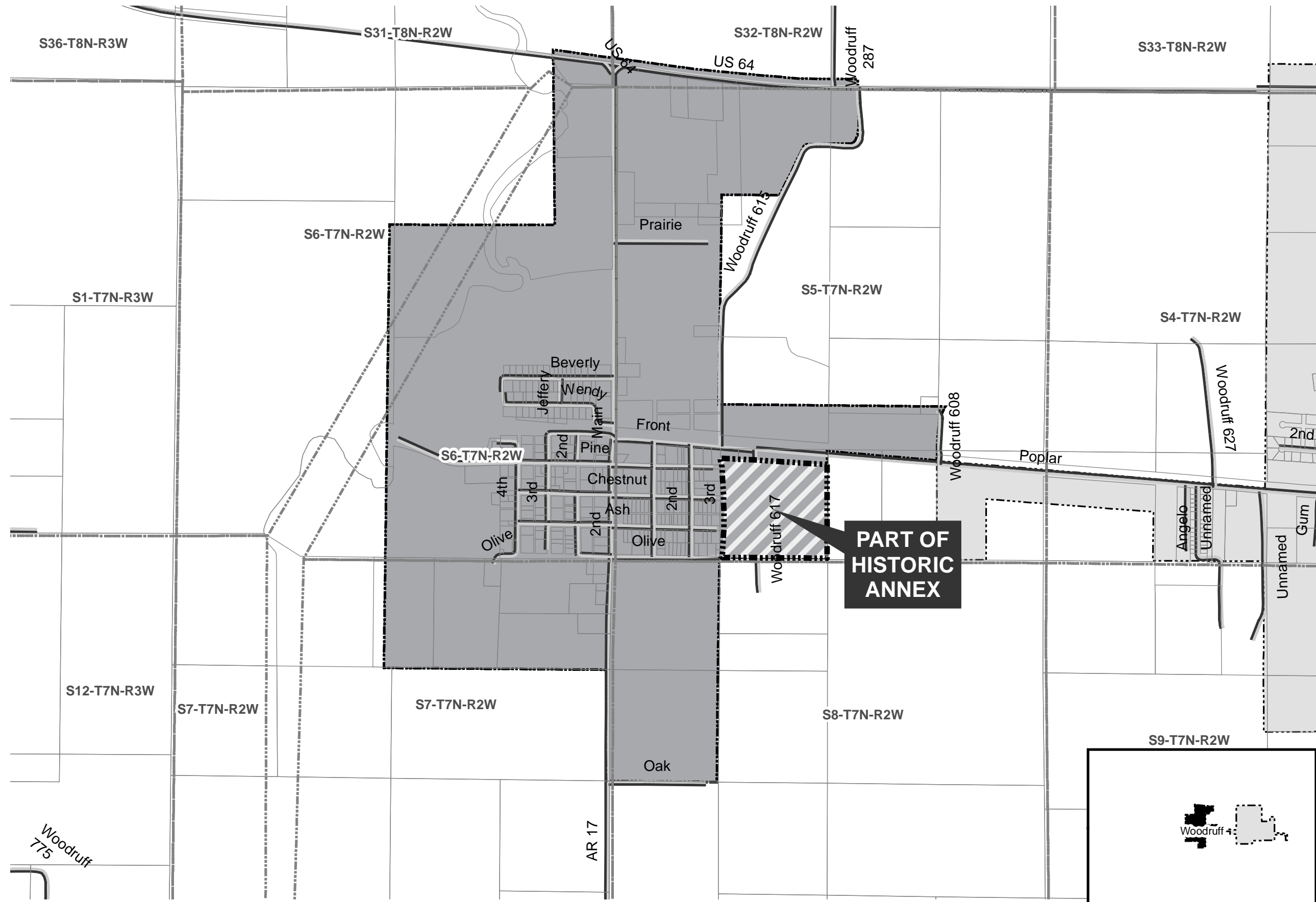

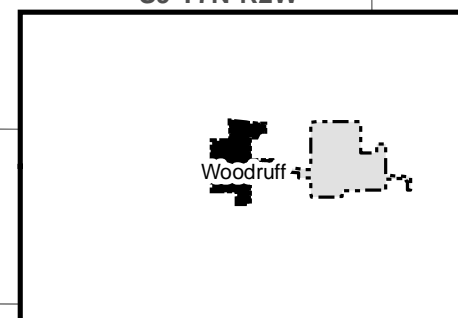
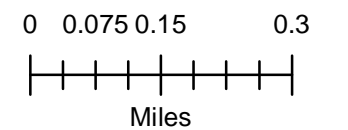
Arkansas Code 14-40-101.

O R D E R.

On this day comes on to be heard the petition of M.H. Patterson, C.S. Garris and more than forty other qualified electors within the territory proposed to be incorporated in the proposed town of Patterson and it appearing to the Court that on the 24th day of May, 1914, a petition in writing, signed by M.H. Patterson and more than twenty others qualified electors within the territory proposed to be incorporated, was filed in this court; their petition describing the territory proposed to be embraced in a town to be called Patterson, Arkansas; annexed to which there is an accurate map and plat; and in said petition, named M.H. Patterson as authorized to act in behalf of the petitioners; whereupon this court fixed this the 26th day of June, at two o'clock P.M.; as the time for the hearing of the said petition, and named M.H. Patterson as agent for said petitioners. And the Court finds that the said petitioners and their agent have given the notice required by law by publication in a newspaper of general circulation in the County of Woodruff in the manner and for the time required by law, of this hearing proof of the publication of said notice being filed herein.

And the Court further finds that more than twenty qualified voters, residing within the limits described in said petition, have signed this petition and that said limits have been accurately described and that an accurate map and plat have been filed and that the name "Patterson" that is proposed for the said town is proper and sufficient to distinguish it from other towns of a like kind; and the court further finds that it is right and proper that the said petition shall be granted, and there being no objections filed against or persons appearing contesting the prayer of the said petition, it is therefore considered, ordered and adjudged by the Court that the territory within the hereinafter described limits be, and the same is hereby organized and is declared to be the incorporated town of Patterson, to-wit:

Beginning at the south-west corner of the south-east quarter of section 6, township 7 north, range 2 west; thence north 240 rods to a stake; Thence east to the north-east corner of the south-west quarter of the north-west quarter of section 5, township 7 north range 2 west; Thence due South to a stake, said stake being 118 feet north of the

north-east ~~corner~~ corner of the south-west quarter of the south-west quarter of section 5, township 7 north, range 2 west; thence in an easterly direction along the north boundary line of the right of way of the Memphis Branch of the St. Louis, Iron Mountain & Southern Railway Company to the north-east corner of the south-east quarter of the south-west quarter of section 5, township 7 north, range 2 west; Thence south to the south-east corner of the south-west quarter of section 5, township 7 north, Range 2 west; Thence East to the north-east corner of the north-west quarter of the north-west quarter of section 3, township 7 north, range 2 west; Thence south to the south-east corner of the south-west quarter of the north-west quarter of section 3, township 7 north, range 2 West; thence west to the south west corner of the south-west quarter of the north-west quarter of section 3, township 7 north range 2 west; thence North to the north-west corner of the south-west quarter of the north-west quarter of section 3, township 7 north, range 2 west; Thence west to the south-west corner of the north-west quarter of the north-east quarter of section 7, township 5 north, range 2 west; Thence North to the point of beginning.

And it is further ordered and directed that this order be endorsed on said petition and that the same be delivered to the recorder of the Northern District of Woodruff County.



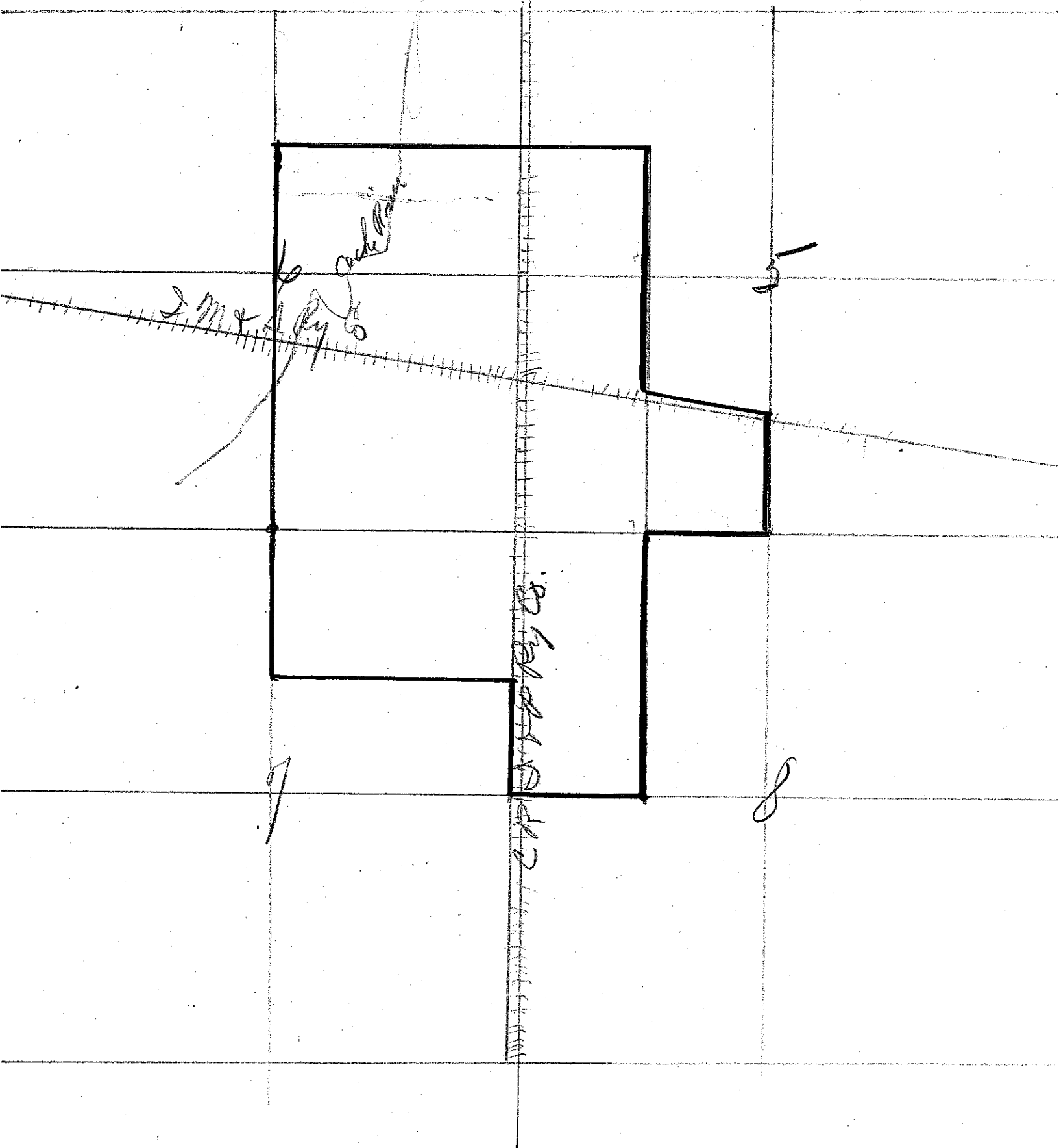
