AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRIFORMATY, AR. TO THE CITY OF PERLA, ARKANSAS AND MAKING SAME A PART OF THE CITY OF PERLA, AND ASSINGING SAME TO WARDS.

BY May a transfer to the control of the city of perla, and assinging same to wards.

WHEREAS, A petition was filed with the County Clerk of Hot Spring County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Perla, Arkansas: and


